#### **Candidate Biography:**



Howard Q. Zhang: For President-Elect

Dr. Howard Zhang is the Director for the USDA ARS Western Regional Research Center in Albany, California. He leads

research on Produce Safety, Plant Mycotoxin,
Foodborne Contaminants, Processed Foods, Bioproduct Chemistry and Engineering, Crop
Improvements and Utilization, Genomics and
Gene Discovery, and Exotic and Invasive Weeds.
WRRC also houses the Plant Gene Expression
Center, ARS Pacific West Area office, Forest
Service Branch and an APHIS laboratory. Dr.
Zhang is a member of the Federal Senior
Executive Service.

Howard was born and raised in Hunan Province of China. He received his BS from Hunan Agricultural University in 1982, MS from the University of Guelph in 1987, and Ph.D. from Washington State University in 1992. He served two years as post-doctoral associate at Washington State University. He was then appointed Assistant Professor (1994-1999), Associate Professor (1999-2003) and Full Professor (2003-2004) at the Ohio State University. In 2004 he joined USDA as Research Leader for Food Safety Intervention Technologies

Research Unit at the USDA ARS Eastern Regional Research Center. He led research on food safety intervention technologies for produce, juices and beverages, and meat and ready-to-eat foods. He was selected as Director for WRRC in 2009.

His areas of expertise include nonthermal processing technologies, pulsed electric fields, packaging, electronic instrumentation and process automation. He is a pioneer and inventor of PEF technology, as the author or co-author of 6 US patents, 97 peer-reviewed journal publications, 18 book or book chapters and 22 papers in proceedings. He has presented 40 invited talks and 146 conference papers.

He received the Institute of Food
Technologists' 2001 Samuel Cate Prescott Award
for Research during his tenure at OSU for his
work on PEF technology. He received the
Research and Development Associates' 2009
Colonel Rohland Isker Award for his team
research and technology implementation of
ultrasonic sealing. He served as Chair of the
Nonthermal Processing Division of IFT in 2002.
He is member of IFT, American Society of
Agricultural and Biological Engineers (ASABE),
Institute of Electrical and Electronics Engineers
(IEEE) and American Chemical Society (ACS).



# **Juming Tang For Director**

Dr. Juming Tang, with BS in China, MS and PhD. in Canada, is a Professor of Food Engineering in the Department of Biological Systems Engineering at Washington State

University (WSU). Dr. Tang's research focuses on developing advanced thermal processing technologies to control pathogens in packaged foods. He was a NASA Summer Faculty Fellow in 2004, the President of International Microwave Power Institute in 2010, and is currently the Chair of IFT Food Engineering Division. He is the Director of WSU Microwave Sterilization Consortium consisting of members from world top food processing and packing companies. Dr. Tang's laboratory patented the design for 915 MHz single mode systems in 2006, received the first ever FDA approval in 2009 for a microwave sterilization process in USA and received the 2<sup>nd</sup> FDA approval in 2010. Dr. Tang has advised 35 Ph.D. students and 8 MS students, published over 190 peer reviewed papers. He is a board member of several food related journals, and has received several research awards, including 2004 Outstanding Research Award from WSU College of Agriculture and Human Resources, 2005 WSU Graduate and Professional Student Outstanding Advisor Award, 2008 Anjan Bose Outstanding Researcher Award from WSU College of

Engineering and Architecture of WSU, and 2010 IFT R&D Award.

quality. Prior to joining

ARS, she had over five years of research and management experience in the produce industry, where she served as a Food Scientist and a R&D Research Leader for the two largest fresh-cut produce companies, Dole Food Co. and Fresh Express Corp. Dr. Luo currently serves on the Food Safety Taskforce in the White House's Office of Science and Technology Policy, and the Food Safety and Technology Council at the United Fresh Produce Association. She is the past chair of the executive committee for the multistate research program on postharvest quality and safety of fresh-cut fruits and vegetables, and a food safety expert for FAO and WHO. She is an author/co-author of over 70 refereed scientific journal articles and invited book chapters, and a recipient of numerous awards from the USDA, IFT, and the produce industry. Her accomplishments have been reported by ARS magazines, Food and Nutrition Briefs, and by newspapers and journals published by industry and scientific communities internationally, and in multiple languages.

Awards: All winners will receive a commemorative certificate, and an invitation to the award ceremony at the CAFS annual banquet. The student scholarship winners will also receive a cash prize.

#### **CAFS Student Scholarship Awards**

#### **Purposes:**

- To stimulate college-bound, high school juniors and seniors to consider majoring in science and technology
- To encourage diligence and excellence in the pursuit of undergraduate studies in food science and technology
- To promote quality and professionalism in scientific research and communication skills among graduate students in food science and technology

#### **Eligibility:**

1. For high school juniors and seniors:

Scholarships are available to the sons and daughters of active CAFS members. Winners are selected based on their academic records, essay,

- two recommendation letters (at least one from school counselor or teacher), and extracurricular activities.
- 2. For undergraduate students: Scholarships are available to those have enrolled in reputable food science and technology programs and are or plan to become CAFS student members at or before 2011 IFT Annual Meeting. Winners are selected based on their academic records, essay, two recommendation letters (if possible, at least one from CAFS professional member), and extracurricular activities.
- 3. For graduate students: Scholarships are available to those are enrolled in reputable food science and technology graduate programs and are or plan to become CAFS student members at or before 2011 IFT Annual Meeting. Winners are selected based on their academic records, essay, two recommendation letters (if possible, at least one from CAFS professional member), extracurricular activities, and scholarly achievements, which will be largely based on the quality and acceptance of an abstract for presentation at the 2010 and/or 2011 IFT Annual Meeting or other professional conferences of food science professional societies such as IUFoST, ACS, ASABE, AIChE, and IAFP. Applications will be evaluated based on two levels, i.e., M.S. or Ph.D.
- 4. A successful applicant may apply again in the following year.

#### **CAFS Scholarship Criteria**:

- Applicant's stated goal consistent with the purpose of the CAFS scholarship;
- 2. Superior academic achievements demonstrating diligence and intelligence;
- Research and/or extra-curricular activities demonstrating leadership, motivation and dedication in the pursuit of studies in food science and technology;
- 4. Observations by professionals (faculty, members, etc.) in recommendation letters.

Application requirement: A letter of application, an essay of career objective, current resume, academic records, and two recommendation letters. For graduate an abstract accepted for presentation at the IFT Annual Meeting or other professional conferences of food science societies in 2010 or 2011.

#### **CAFS Professional Achievement Award**

**Purpose:** To recognize a professional member for his/her outstanding contributions to the field of food science and engineering, as it relates to teaching, research, extension, administration, or leadership in the food industry, academia and government.

**Eligibility:** Active CAFS members only. The winner receives a commemorative plaque and an invitation to the award ceremony at the CAFS annual banquet.

Nomination requirements: Nominator should submit a nomination letter, current resume of the nominee, and two reference letters from current CAFS professional members to the Award Committee.

#### **CAFS Distinguished Service Award**

**Purpose:** To recognize a professional member for his/her outstanding and sustained contribution to CAFS.

**Eligibility:** Active CAFS members only. The winner receives a commemorative plaque and an invitation to the award ceremony at the CAFS annual banquet.

**Nomination requirement:** Nominator should submit a nomination letter, current resume of the nominee, and two reference letters from current CAFS professional members to the Award Committee.

#### **Number of Awards per Year:**

Scholarship awards: high school seniors (1-2), undergraduate (1), graduate (up to 2)
Professional Achievement and Distinguished
Service awards: one each. The awards will only be honored when qualified recipients are identified.

#### **Selection Process:**

Upon receipt of all applications by the deadline, the Award Committee will review the applications and supporting documents. Each committee member will assign a numerical rating on each candidate. Those candidates receiving the highest scores will be the winners. In case of tie in a given category, the committee chair can call for a re-vote.
