CAFS 2010 Annual Meeting and Banquet Highlights

The 2010 CAFS Annual Meeting and Banquet took place at the Phoenix Restaurant in the Chinatown of Chicago on July 19, 2010. This year's banquet was sponsored by the Almond Board of California and was attended by more than 100 guests, members and friends. The banquet started at 6:30 pm with a warm welcome from the CAFS President, Dr. Fur-Chi Chen, followed by introducing guests and members from China (TianJin University of Science and





Technology), Hong Kong and Taiwan (National Taiwan University, National Chung Hsin University, National Taiwan Ocean University, and China Medical University) and new CAFS members. Dr. Chen then gave a sincere appreciation to the Almond Board of California for their sponsorship to the banquet and a special thank to those who have served as CAFS presidents.

Dinner was served with 10 delicious dishes and desserts. Following the dinner, Dr. Joseph Jen gave a Keynote Speech “Challenging Glass Ceiling”. Dr. Jen was born in Chongqing of China and raised in Shanghai/Nanjing area. He received his B.S. degree in Agricultural



Chemistry from National Taiwan University, M.S. degree in Food Science from Washington State University and Ph.D. degree in Biochemistry from the University of California - Berkeley. Dr. Jen first worked at Clemson and Michigan State Universities and then at Campbell Soup Company. He obtained a MBA degree from Southern Illinois University while working at Campbell. He was the Division Chair and Department Head of Food Science and Technology at University of Georgia for 6 years and became the first Asian American to be appointed as the Dean of a major agricultural program in the U.S. at California



Polytechnic State University for 9 years. Dr. Jen was nominated by President George Bush and confirmed by the U.S. Senate as the Under Secretary of USDA in charge of Research, Education and Economics from 2001 to 2006. He was the founder of Chinese American Food Society in 1975 and the keynote speaker of 2002 IFT Meeting. He has received many awards and recognitions from various organizations and governments. Dr. Jen first briefly mentioned the history of CAFS and then gave a speech of his own perception of glass ceiling and how he managed to break the glass ceiling with a focus on mind set, skill, networking and luck.



Following Dr. Jen's speech, Dr. Chen reported a few key issues and activities of CAFS for the past year and expressed his sincere appreciation to the 2009-2010 Officers and Committee Chairs for their diligent service. Congratulations were given to Dr. Alice Cha of Kraft Foods, Dr. Rui Hai Liu of Cornell University, and Dr. Youling Xiong of University of Kentucky for being elected 2010 IFT Fellows.

Dr. Chen, on behalf of the Chair of Award Committee (Dr. Hongda Chen), presented the 2010 CAFS Professional Achievement Award to Dr. Faye Dong of Department of Food Science and Human Nutrition of University of Illinois, 2010 CAFS Graduate Student Scholarship Awards to Jie Wei (Ph.D. candidate) of University of Delaware and Xiao Guo (M.S. candidate) of University of Maine, and 2010 CAFS High School Scholarship Award to Sonya Liu of Highland High School in Pocatello of Idaho.

Dr. Hong Zhuang, Chair of Nomination Committee, announced the CAFS 2010 election results and 2010-2011 officers: President: Dr.

Albert Hong, President Elect: Dr. Yi-Cheng Su, Secretary: Mr. Guangwei Huang and newly elected Directors (2010-2011): Dr. Xuotong Fan and Dr. Hang Xiao. Dr. Dongsheng Guan (Director), Dr. Howard Zhang (Director), Dr. Vivian C.H. Wu (Treasurer), Dr. Qixin Zhong (Membership Director) and Dr. Haiqiang Chen (Web Communication) will continue to serve on the Executive Committee for 2010-2011.

As the banquet went to the end, more than 25 door prizes including four \$25 gift certificates from Starbuck Coffee were drawn. Dr. Fur-Chi Chen introduced the coming year President, Dr. Albert Hong. IFT 2010 Fellow, Chicago, IL, July 17-20, 2010:

Dr. Alice Cha, Research Principal in Ingredient and Process Research, Kraft Foods-Glenview Technology Center, was recognized for being an expert in hydrocolloid chemistry and its application in food texture as well as for her in-depth knowledge of ingredient interactions in food products.

Dr. Rui Hai Liu, Associate Professor, Cornell University, was honored for his expertise on bioactive compounds, functional foods, and nutraceuticals, and for his innovative work in whole food synergy and bioactive compounds in the prevention of chronic diseases.

Dr. Youling Xiong, Professor, University of Kentucky, was honored for his innovative research on protein and peptide functionality and muscle food processing and his sustained contributions to food science and technology education.

Fellow of IAFOST (the International Academy of Food Science and Technology), Cape Town, South Africa, August 22-26, 2010:

Dr. Joseph Jen, was nominated in 2001 by President George Bush and confirmed by the U. S. Senate as the Under Secretary for Research,

Education and Economics of U. S. Department of Agriculture. As such, he was the highest ranked U.S. Federal Government officer born in

China mainland in the U.S. history. He was also the first food scientist to break into the rank of Under Secretary at USDA. He was known for his support to genomics and obesity research and established strong collaborative research between China and USDA. He returned to

California in 2006 and has been active in food safety issues at IUFOST and China. He was named as Honorary Professor at China Agricultural University and Shanghai Jiao Tong University and is the North America editor of Food Control journal.

How to be a Fellow in Professional Associations?

Besides CAFS membership many of you also belong to societies such as IFT, ASM, Food Chemistry, etc. In these societies they have awards for Excellence, Achievements, Services, etc. for special members. The 2010 Banquet Sponsor Received the President's Award from IU FoST

The Almond Board of California (ABC), the sponsor for CAFS 2010 Banquet, was honored with the inaugural President's Award by International Union of Food Science and Technology (IU FoST) at the 15th World Congress of Food Science and Technology. IU FoST recognized ABC for its leadership in encouraging young scientists and student exchange and education, and for its promotion of and support for food safety efforts around the world. On behalf of ABC, Guangwei Huang, Principal Scientist, accepted the award from IU FoST president, Dr. Geoffrey Campbell-Platt at the Congress sharing the podium with representatives from other five recipients of the President's Award: Cargill, JDB Group, Nestle,



Beijing Air Catering Company and Mengniu Dairy Group; and representatives from the winning companies with the IU FoST Global Food Industry Innovation Awards. ABC was nominated by the Chinese Institute of Food Science and Technology (CIFST) for its long time collaboration with CIFST and contribution in promoting food science education in China, and in participating in its outreach activities in food safety and innovation with natural ingredients. ABC has an on-going collaboration with CIFST in conducting an annual student almond innovation competition among Chinese universities with food science and technology program.

ABC launched its first almond-focused innovation competition at Jiangnan University in 2004. Within a few years, ABC joined forces with CIFST to expand the competition. The 2009 competition involved about 3000 students from 36 universities. The 2010 competition is ongoing now. Overall, more than 12,000 students have participated in the last six competitions, and more than 200,000 university

students and their instructors have been informed of these events. The competition is designed to educate future Chinese food technologists about choosing healthy and complementary ingredients to make foods that will benefit consumers, and to provide practical training in food innovation. The ABC sponsored student innovation competition has become a

model that many international and Chinese food companies are following that have created an exciting atmosphere in food innovation among Chinese universities. ABC's commitments and efforts in promoting food innovation and food science education were highlighted in a poster presented at the congress.
